## Declaration of Conformity to REACH Regulation (EC 1907/2006), SVHC Candidate List of June $27^{th}$ , 2024

The EU REACH Regulation (1907/2006) deals with chemical substances and their potential effects on human health and the environment. Annex XVII of the REACH Regulation defines limit values for about 241 substances for specific use cases and product categories.

As an importer and supplier of products, we are obliged under REACH to ensure that the products we supply do not contain any Substances of Very High Concern (SVHC) in a concentration greater than 0.1% by mass.

We assure you that all products imported and traded by us are carefully checked and that they are REACH-compliant. We are in close exchange of information with our suppliers on this subject.

Should we become aware of information that limit concentrations are exceeded in any products we are importing and supplying, we will inform the supply chain via our delivery notes and order confirmations for the products concerned.

Furthermore, we are aware of our registration and notification obligations under Article 7 of the REACH Regulation, which requires registration or notification of articles to ECHA.

#### Declaration of Conformity to POP Regulation (EU) 2019/1021, Annex I.

(EU) 2019/1021 deals with the production and use of persistent organic pollutants (POPs).

These are chemical substances that are persistent in the environment, bioaccumulate through the food chain and pose a risk to health and the environment. The regulation defines prohibitions of use as well as concentration limits for substances in articles for certain product classes.

We assure you that all products imported and traded by us are checked in terms of the POP Regulation and, according to the information available to us, do not contain any of the substances listed in the Regulation.

### **Conflict Minerals Statement under Regulation (EU) 2017/821**

On January 1, 2021, Regulation (EU) 2017/821 establishing supply chain due diligence obligations for Union importers of tin, tantalum, tungsten, their ores and gold from conflict and high risk areas entered into force.

In politically unstable areas, the trade in minerals can finance armed groups, promote forced labour and other human rights abuses, and support corruption and money laundering. The EU Conflict Minerals Regulation aims to ensure that responsible international sourcing standards are met.

At present, we have no information that conflict minerals are used in our supply chains that directly or indirectly finance violent conflict and human rights abuses.
